#### INNOVATION

Radical innovation (new product unknown to the market using a new technology) Continuous innovation (improvement in the existing product).

#### **MARKET FEASIBILITY**

Analyze different factors related to the market to determine whether or not the product will be marketed.

#### **INTEGRATION OF NEW TECHNOLOGIES**

The incorporation of new technologies that can bring relevant improvements to competitiveness.

### **GREATER EFFICIENCY IN PRODUCTION AND/OR DISTRIBUTION**

The intention is to use as few resources as possible in order to generate more.

#### **ENERGY EFFICIENCY**

The improvement of energy efficiency has been a relevant factor in the processes, companies have seen the need to move along with new technologies as it is one of the main tools that can be used to increase productivity and production save production costs.

#### SUSTAINABILITY, WASTE, CIRCULAR ECONOMY

A smart, innovative and sustainable plastics industry, where design and production fully respect the needs of reuse, repair and recycling.

**1)** All information provided by participants will be treated with the utmost confidentiality until the publication of the registered proposals in November 2023.

**2)** By participating, the contestants accept the rules and that the jury's decision is final and and not subject to appeal.

- 3) The proposal must include:
  - **a.** Title
  - **b.** Description of the functions / mechanisms and benefits of the project (300 words, text in Times New Roman, font size 11)
  - c. Information on the approximate cost of investment and operation
  - **d**. Video of no more than 90 seconds showing the application and operation of the submitted work. A YouTube link must be submitted.
  - e. Three high resolution images of the project (minimum 300 dpi)
- 4) Submissions that do not comply with the registration procedure described above will not be considered.
- 5) The nominated proposals will be notified directly by the organizers in October. The nominees should NOT communicate the nomination to other participants until the official announcement is made within the framework of PLASTIMAGEN<sup>®</sup> MEXICO.

# THE JURY

The qualifying jury is made up of distinguished professionals and experts in the sector who will carefully evaluate all submissions and identify three works as nominees for the award according to their category.

- The jury will meet at the end of October 2023 to make the final evaluation and selection of the nominees
- The jury may reassign a proposal to a different category if it finds it inappropriately placed
- If the jury considers that the proposals do not meet minimum quality requirements, the award may be declared void.
- The decision of the jury is not subject to appeal
